



Milton Frank Adam, 82, a 42-year resident of Sun Valley, Idaho, passed away Nov. 25, 2017, in Twin Falls, Idaho.

He was born in Chicago, Ill., on June 9, 1935, to Frank (a baker) and Agnes (Nemecek) Adam (a seamstress). He grew up in Cicero, Ill., and was a June 1953 graduate of JS Morton East High School.

Joan Hahn Obituary

Jerry Scheid - Founding Board Member (living)

Served from 1983-1994



I was born in 1936 and grew up in the little town of Jerome, Idaho. My father was in the sheep business and my early memories, as soon as I was old enough, are of going with my father and helping with the sheep. Our part of the sheep industry here in Idaho was to buy ewe lambs, overwinter them and then trail them to our summer range in Montana's Centennial Valley. The trip took about three months with 4,000 to 6,000 yearling ewes and was an adventure that I got to share in every spring as soon as school was out. The sheep spent the summer on the Montana ranch and were sold in the fall as replacement stock to large ewe and lamb operations in Idaho.

I attended school in Jerome until the end of my sophomore year. I then attended the New Mexico Military Institute and graduated there in 1955. I then attended the University of Colorado for two years until my father's health problems made it necessary for me, being the only child, to return home and become involved in the business. As part of my formal education, I later received an associate degree in Farm Business Management from Idaho State University.

In the early sixties, I took over the family ranching business, which now included a cow-calf and yearling steer operation. Charles Rice Obituary

Charles "Chuck" Merton Rice, a longtime Idaho Falls business and community leader, passed away Monday, Sept. 2, 2013. While noted for his endless volunteerism and philanthropy, Chuck often stated that his greatest joy and contribution was in family.

Chuck was born the second child to Allen Buckner Rice and Ethel Kaake Rice in Whitmore Lake, Mich., on Jan. 26, 1925. Having graduated from high school at 16, he enrolled at Wabash College, where he ran on the track team and graduated with a science degree. Post-graduate work was recognized by the Oak Ridge School of Reactor Technology with a subsequent master's degree awarded in physics from the University of Missouri-Rolla.

Rice served his beloved America as a communications expert for the U.S. Navy in World War II.

In 1947, he married Mary Esther Buelteman. They had eight children from 1950 to 1960.

Chuck's early contributions included design work for the U.S. Army's ML-1 mobile low power portable nuclear power plant, management of the Army Gas-Cooled Reactor Systems program and the AEC/NASA Nuclear Rocket Program (NERVA).

After nearly a dozen moves, Rice stated that when he arrived with his family in Idaho Falls in 1969, he had found a permanent home. He was right. Chuck served as president and CEO of both the Idaho Nuclear Corporation and Aerojet Nuclear Corporation, with responsibility for management of the Idaho National Engineering Laboratory. In 1972, he founded the first successful technology spinoff company from the INEL -- Energy Incorporated. He went on to do management consulting in fields ranging from utility/regulatory disputes, nuclear power plant operation management and space defense initiative efforts.

Chuck was involved in professional associations over the years, including service as chair of the Technology Advisory Board of EITC; chair of the INL Citizens Advisory Board; member of the Engineering Advisory Council and a President's Associate at ISU; board member of Development Workshop Incorporated; fellow and charter member of the American Nuclear Society; and member of the American Society of Mechanical Engineers.

Also known for his community connections, Rice played a significant leadership role in the local Rotary Club, CHC Foundation, United Way, Bonneville Museum Foundation, Hospice of Eastern Idaho, SCORE and Idaho Foundation for Parks and Land.

Education and family were always paramount to Chuck. He was instrumental in encouraging and helping to finance the higher education of his children, grandchildren and many other family and friends.

He was preceded in death by his parents; three siblings; his oldest son, Greg; and granddaughter, Stacey Heim.

He is survived by his children, Jo Finne of Seattle, Gayle Eaton of Donnelly, Maribee Sovereign of Hayden, Steve Rice of Portland, Randy Rice of Idaho Falls, Mike Rice of Clarkston and Ginny Kuhl of San Clemente. He leaves behind his beloved 14 grandchildren and 22 great-grandchildren.

Ron Lechelt grew up in Britt, Iowa and attended medical school at the University of Iowa. He completed his pediatric residency at Blank Children's Hospital in Des Moines.

But Sister Dominica, who worked with the babies, loved them, held them, and kissed them. She always ignored my reminders to wear a mask. She was always in there, day and night, taking good care of those babies. The other sisters were equally involved in the care and management of the hospital, from administrators to pharmacists. They were a wonderful bunch."

Having worked with organizations who had benefitted from CHC grants, and having such close ties with the Sacred Heart Hospital, Ron was delighted to join the board in 2007. He served for 11 years, including a 2-year terms as president, until he and his wife moved out of the area. He enjoyed being a part of building up southeast Idaho, including being a part of funding a community center in Moore and an ice skating rink in Teton.

Now, in 2024, Ron and Nancy split their time between Palm Springs, California and Missoula, Montana. They love to swim, golf (Ron), play volleyball (Nancy), and stay connected with friends. They attend Immanual Lutheran Church in Missoula, where Ron sometimes gets to play the bongo drums. Ron and his wife are the parents of four daughters.

Theron is an Arkansas native who transplanted to Idaho in 1990. Prior to joining Idaho National Laboratory (INL), he worked on a demilitarization project for the Department of Defense in Arkansas. At INL, Theron has held positions in Chemistry, Integrated Safety Management, Contracts Management, and is currently the Department Manager for INL's Performance Assurance Organization.

Theron has held leadership roles on various Department of Energy boards and corporate committees including the Energy Facility Contractor's Group (EFCOG), the Battelle Integrated Performance Management Community of Practice, the Performance

Analysis Functional Area Coordination Team (PA FACT) for Amentum, and he served as president and is the current operational strategist of Prism, INL's Leadership Council supporting Lesbian, Gay, Bisexual, Transgender, Queer, and Ally employees.

In addition to his career at INL, he has been a strong advocate for the LGBTQ community. Self-termed a "reluctant advocate," his custody decision and subsequent appeal of that decision thrust Theron into the national spotlight. As the first LGBTQ parental rights case following the landmark Lawrence Decision (Lawrence v. Texas 2003 SCOTUS), Theron's appeal to the Idaho Supreme Court (McGriff v. McGriff 2004 Idaho Supreme Court) established legal precedence for LGBTQ parental rights cases in all 50 states.

Theron has supported many community organizations and served on numerous boards. He and his husband are among the founding members of a local non-profit organization, Breaking Boundaries, which supports inclusion and diversity programs. Theron has held positions on the Idaho Falls Symphony Board of Directors, the Community Hospital Charity Foundation Board of Directors, and supported the Idaho Falls' Arts Council.

Theron has received numerous awards and honors for his volunteer efforts including The President's Call to Freedom Award, he was honored by the National LGBTQ Bar Association and Lambda Legal as a "Pioneering Parent," and the INL Laboratory Directors' Inclusive Diversity Award. In 2018, Theron was honored by the Idaho Historical Museum in Boise Idaho and is included in their permanent exhibit of "Stories of Idaho." In 2020, Theron received the Governor Cecil Andrus Volunteer of the Year award for the State of Idaho.

Theron holds a BS in Chemistry from the University of Arkansas and a MS in Hazardous Waste Management from Idaho State University. He and his husband, Nick, have 2 adult daughters, Payton and Callan. Their family added a son-in-law Dylan in 2018 and grandson Rowen in 2020. Theron and Nick now make their home in Las Vegas, Nevada.
